4. Tolling system and tolling technologies used

Tolling system

The following ways of collecting toll exist in Slovenia:

- Vignette tolling system for vehicles weighing up to 3.500 kg;
- DarsGo system (electronic tolling system in free traffic flow) for vehicles weighing over 3.500 kg – since 1 April 2018 (before we had an open and closed tolling system).

Vignette tolling system is intended for vehicles with the maximum permissible weight up to 3.500 kg, regardless of the maximum weight of the trailer. You have to buy a vignette if you want to use a toll road.

DarsGo is a modern electronic tolling system in free traffic flow, which applies to vehicles whose maximum permissible weight exceeds 3.500 kg.


Tolling is made possible with the help of a special DarsGo unit, which is installed in the vehicle. The tollable motorway and expressway network with the total lenght of 623,4 km is divided into 128 toll sections. Each section hosts a tolling gantry above the motorway, through which a vehicles passes. The gantry detects the DarsGo unit installed in the vehicle as it passes, which serves the basis for charging toll for the travelled section. Tolling is completely automatic, and the price is based on the distance driven.





The toll rates in the electronic toll system are published in the Tariff for the use of toll roads. The toll rate for each toll section depends on:

- the vehicle type or vehicle toll-rate category,
- the EURO emission class and
- the distance driven.

Toll-rate categories:

- R3 (first toll-rate category): motor vehicles having two or three axles whose maximum permissible weight exceeds 3.500 kg, and groups of motor vehicles with two or three axles whose maximum permissible weight exceeds 3.500 kg.
- R4 (second toll-rate category): motor vehicles having more than three axles whose maximum permissible weight exceeds 3.500 kg, and groups of motor vehicles with more than three axles whose maximum permissible weight exceeds 3.500 kg.

7. Significant actions achieved in 2018 and foreseen for 2019

Openings in 2018

Second stage of construction of the Motorway A4 Slivnica-Gruškovje from km 7.26 to km 13.03 was completed in November 2018 and the opening of the last 5,77 km of the 13 km long motorway was on 30 November 2018. We managed to open it before the due date as the end of the contract period was 5 January 2019.

Significant actions foreseen for 2019

Start of the construction of the second tunnel tube for the Karavanke road tunnel on the cross-border section Austria-Slovenia is anticipated for the second half of 2019. The tunnel is located in the TEN-T network and connects the A2 MW in the Republic of Slovenia with the A11 MW in the Republic of Austria. This is a cross border project, which will receive a grant in a max amount of 7,950,000 € under CEF facility (or 10% of the eligible cost) on Slovenian side.
