

- ✓ Improve safety of road users by developing safer road infrastructure
- ✓ Possibility of extending the application of infrastructure management principles beyond the TEN-T

VEHICLE SAFETY

- ✓ Vehicle safety:
 - Redesigning car fronts to include pedestrian & cyclist protection
 - Intelligent Speed Assistance
 - Automated Emergency Braking



AUTOMATED VEHICLES: PORENTIAL SAFETY CHALLENGES

- ✓ New collision types?
- ✓ Interaction: automated vs. nonautomated
- ✓ Interaction: vulnerable road users; road infrastructure
- ✓ Driver engagement and reengagement





Enforcement

- ✓ EU fund and best practice to enable enforcement of main killers: speed, alcohol/drug driving, non use of seat belts, distraction and fatigue.
- ✓ Revise CBE Directive to overcome bottlenecks.



Road Operators: Over to you

- Motivate Ministers at National Level to act on Road Safety and support EU action.
- ✓ Further improve high safety standard of infrastructure safety on ASECAP networks.
- ✓ Co-operation with enforcement agencies on enforcement especially speed, distraction, fatigue.
- ✓ Ensure road network can support new vehicle safety technologies.
